

Admission Requirements

Provided that the candidates are in the last year of high school or have graduated;

- 1) Foreign nationals,
- 2) Those who were born Turkish citizens but have obtained permission from the Ministry of Interior to renounce Turkish citizenship and their non-adult children listed in their Turkish citizenship renunciation documents as holders of the "Document Regarding the Exercise of Recognized Rights," (According to the Article 7 of Law No. 5901 on Turkish Citizenship, "A child born to a Turkish mother or through a Turkish father within the unity of marriage either in Turkey or abroad is a Turkish citizen", those who will apply for admission quotas from abroad are advised to examine the Turkish Citizenship Law),
- 3) Those who have acquired Turkish citizenship later by means of dual citizenship or by switching from foreign citizenship to Turkish citizenship,

4)

- 1) Among the Turkish students who continued their secondary education abroad before 01/02/2013, those who completed the last three years of their secondary education in a foreign country excluding the TRNC (including those who completed their secondary education in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC),
- 2) Among the candidates who started secondary education abroad after 01/02/2013, those who completed their entire secondary education in a foreign country excluding the TRNC according to the admission quota abroad (including those who completed their secondary education in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC),
- 5) Those who are TRNC nationals, residing in TRNC and have completed secondary education in TRNC and have GCE (A-Level) exam results, and those who have or will have GCE (A-Level) exam results by registering and studying at colleges and high schools in other countries between 2005-2010 will be accepted.

Cases Where Registration Cannot Be Completed

Candidates falling under the following categories:

From the candidates,

- 1) Turkish citizens who have completed their entire secondary education in Turkiye or the Turkish Republic of Northern Cyprus (TRNC).
- 2) TRNC citizens (excluding those who have completed their entire secondary education in TRNC high schools and have GCE (A-Level) results, as well as those who have registered at and







received an education in schools in other countries between 2005 and 2010 and have or will have GCE (A-Level) exam results).

- 3) Dual citizens defined in Article 4, Paragraph 1, Sub-paragraph (b), who have Turkish citizenship as their first citizenship, (except those who meet the conditions specified in Article 4, Paragraph 1, Sub-paragraph (c)).
- 4) Dual citizens, one of whose citizenships is TRNC (excluding those who have completed their entire secondary education in TRNC high schools and have GCE (A-Level) results, as well as those who have registered at and received an education in schools in other countries between 2005 and 2010 and have or will have GCE (A-Level) exam results).
- 5) Turkish citizens studying at schools within Turkish embassies and foreign high schools in Turkiye, as well as dual citizens defined in Article 4, Paragraph 1, Sub-paragraph (b), who have Turkish citizenship as their first citizenship.
- 6) Those who have been expelled from any higher education institution in Turkey.

Their applications will not be accepted. Candidates falling under this provision cannot be registered at the University. If such a situation is determined after registration, the student's affiliation with the University will be terminated.
