

## Conditions for Applicants Applying for Admission from Abroad

**Applications from candidates who meet the following conditions will be accepted, provided they are in their final year of high school or have graduated:**

1. Applications will be accepted from candidates who meet the following conditions:
  - a) Foreign nationals (provided they enrolled in Turkish secondary education institutions before the 2022-2023 academic year, excluding embassy schools, international private education institutions listed in the MOBIS system, and foreign nationals brought to Turkey within the framework of projects carried out by the Ministry of National Education).
  - b) Those who were Turkish citizens by birth but lost their Turkish citizenship with the permission of the Ministry of Interior, and those who can document that they hold a blue card (provided they enrolled in Turkish secondary education institutions before the 2022-2023 academic year). According to Article 7 of the Turkish Citizenship Law No. 5901, "(1) A child born in or out of wedlock from a Turkish citizen mother or father within the marriage union is a Turkish citizen." Applications from candidates who will apply to quotas from abroad will be evaluated within the provisions of the Turkish Citizenship Law.
  - c) Those who acquired Turkish citizenship after being foreign nationals / dual nationals in this situation (provided they enrolled in Turkish secondary education institutions before the 2022-2023 academic year).
  - d) Turkish citizens who completed their entire secondary education (high school) in a foreign country except for the TRNC (including those who completed their entire secondary education in Turkish schools opened under the auspices of the Ministry of National Education in a foreign country except the TRNC).
  - e) TRNC nationals who reside in the TRNC, have completed their secondary education (high school) in the TRNC and have GCE AL exam results, and those who enrolled in colleges and high schools in other countries between 2005-2010 and have or will have GCE AL exam results.
2. Applications from candidates who meet one or more of the following conditions will not be accepted, and even if they have applied, they will not be registered:
  - a) Turkish citizens who completed their entire secondary education (high school) in Turkey or the TRNC.
  - b) TRNC nationals (except those who completed their entire secondary education (high school) in TRNC high schools and have GCE AL exam results, and those who enrolled in colleges and high schools in other countries between 2005-2010 and have or will have GCE AL exam results).
  - c) Dual nationals whose first nationality by birth is Turkish as defined in the second clause of the first article (except those who meet the conditions in clause d of the first article).
  - d) Dual nationals one of whose nationalities is TRNC (except those who completed their entire secondary education (high school) in TRNC high schools and have GCE AL exam results, and those who enrolled in colleges and high schools in other countries between 2005-2010 and have or will have GCE AL exam results).
  - e) Turkish citizens or dual nationals defined in clause b of the second article whose first nationality by birth is Turkish, who study in schools within the embassies in Turkey or foreign high schools in Turkey, and who will enroll in Turkish secondary education institutions from the

2022-2023 academic year onwards, TRNC citizens and those who have left Turkish citizenship / blue card holders and foreign nationals (excluding embassy schools, international private education institutions listed in the MOBIS system, and foreign nationals brought to Turkey within the framework of projects carried out by the Ministry of National Education).
